

**CORPUS CHRISTI REGIONAL ECONOMIC DEVELOPMENT CORPORATION**

**DUTIES:** To perform as an advisory board to the City Council and to investigate and recommend to the Council such projects as in its opinion would be advantageous to the future growth of the City and to assist the City in the establishment and location of industries.

**COMPOSITION:** Fifteen (15) directors, four (4) directors appointed by the City Council for three-year staggered terms and one (1) director (Council Member) appointed by the Mayor of the City of Corpus Christi. The remainder of the Board shall be comprised of not more than seven (7) persons elected by the Corporation's membership in accordance with its bylaws, two (2) appointed by the Port; the Mayor shall also serve as an ex-officio, voting director. The City Manager and Port Director shall serve as ex-officio, non-voting members. The directors shall serve not more than two, consecutive, three-year terms staggered as provided in the Corporation's bylaws; provided that the term of office of any director who is a public official shall coincide with his or her term of public office.

**CREATION & AUTHORITY:** Corporation established under 501 (c) (6) of the Internal Revenue Code and its regulations. M2000-31, 1/25/00; M2000-53, 2/22/00; M2004-382, 10/12/04. Amended Bylaws 8-9-07.
