

REGIONAL HEALTH AWARENESS BOARD

DUTIES: To connect public, government and industry on issues regarding health, safety, and the government.

COMPOSITION: The Regional Health Awareness Board is made up of thirteen (13) voting members representing a cross-section of health, environmental, and social interest. Two (2) of these community members will be appointed by the City Council, two members will be appointed by the Commissioners Court Nueces County, and two members will be appointed by the Commissioner Court San Patricio County for three-year terms. At-large members are appointed to three-year terms as follows: 1-City of Corpus Christi, 1 – Nueces County, 1 – San Patricio County, 2 – Port Industries of Corpus Christi, 1 – Texas A & M –Corpus Christi, and 1 – Texas A & M – Kingsville. Additionally, there are four (4) ex-officio/non-voting representatives, one (1) from each of the following agencies: Texas Commission on Environmental Quality, Environmental Protection Agency, Nueces County/City of Corpus Christi Public Health District and San Patricio County Department of Public Health.
