A move outside the city limits of the city by any member shall constitute automatic resignation from the particular board or commission on which such member served.

City Code of Ordinances, Section 2-61, provides that absences from more than 25% of regularly scheduled meetings during a term year on the part of any board, commission or committee member shall result in an automatic termination. An absence shall be deemed unexcused unless excused by the board, commission or committee for good cause no later than it next meeting after the absence.
